## Spouse Tax Transcript for 2017

Your spouse's 2019-2020 FAFSA was selected for review in a process called "Verification." In this process, the financial aid office will compare the information reported on your FAFSA with the information on this form and any other required documentation. The law states that we have the right to ask for confirmation of this information before awarding federal student aid. You and your spouse whose information was reported on the FAFSA must sign this form, attach any required documentation, and submit the completed package to the LCC Financial Aid Office. If there are differences between the information reported on your FAFSA and the documents submitted to our office, we will make the necessary corrections. We retain the right to request additional information as needed to complete your spouse's file. If you have any questions about the verification process, contact the Financial Aid Office as soon as possible to avoid a delay in processing your spouse's request for financial aid.

**\*\*Your spouse's eligibility for financial aid cannot be determined until the verification process is complete.\*\***

The income tax documents that we accept are based on policy put forth by the U.S. Department of Education. We can only accept a **2017 IRS Tax Return Transcript** or a copy of your **2017 Tax Return** signed by you or with the necessary tax preparer information as documentation of tax information

## 1. Tax Return Transcript

### Online:

Go to [www.irs.gov/transcript](http://www.irs.gov/transcript)

Request the transcript online by selecting "Get Transcript Online" or by mail by selecting "Get Transcript by mail. Follow the on-screen instructions.

### By Phone:

Call the IRS Transcript Order Line at **1-800-908-9946**.

Follow voice prompts to order 'Tax Return Transcript' for year '2017.'

### In Person:

Set up an appointment with your nearest IRS facility by calling **844-545-5640**

## 2. Tax Return (1040)

If you submit a copy of your 2017 Tax Return, it **MUST** contain either your signature or the necessary tax preparer information (SSN, EIN, or PTIN) and has been signed, stamped, typed, or printed with the name and address of the preparer of the return

**Once you obtain the Tax Return Transcript/Tax Return, return it to Lenoir Community College by Mail, Fax, or In Person.**

- If marital partners filed separate 2017 IRS income tax returns, the 2017 IRS Tax Return Transcripts must be provided for each parent.

### Individuals Who Filed an Amended IRS Tax Return

If an individual filed an amended IRS income tax return for tax year 2017, provide both of the following:

1. A signed copy of the original 2017 IRS income tax return that was filed with the IRS or a **2017 IRS Tax Return Transcript** (signature not required) for the 2017 tax year; **AND**
2. A signed copy of the 2017 IRS Form 1040X, "Amended U.S. Individual Income Tax Return," that was filed with the IRS.

### Individuals Who Were Victims of IRS Identity Theft

- A victim of IRS identity theft who has been unable to obtain a **2017 IRS Tax Return Transcript** or use the IRS DRT. Must provide a signed copy of the 2017 paper IRS income tax return that was filed with the IRS and a signed copy of IRS Form 14039 "Identity Theft Affidavit" that was submitted to the IRS.

### Individuals Who Filed Non-IRS Income Return

- If an individual filed or will file a 2017 income tax return with Puerto Rico, another U.S. territory (e.g., Guam, American Samoa, the U.S. Virgin Islands, the Northern Marianas Islands), or with a foreign country, provide a signed copy of that 2017 income tax return(s).
