Certificate/Class Credit Information

100% attendance is required for OSFM certification courses. Attendance will be taken twice on each day of class. Certificates will be mailed to all participants.

Minimum Age Requirements

The minimum age for participation in the Lenoir Community College Public Safety School is 16 years of age. All participants between the ages of 16 – 18 and currently attending high school must have concurrent enrollment forms signed by the high school principal.

Concurrent Enrollment forms must be returned with the registration.

Enrollment for participants 16 –18 years of age and a current high school student will be limited only to classes that **do not** state; *Students must meet minimum age requirement (18 years of age or older).*

FIP 3043 FF Fireground Ops 3 (32 hours)

Section #2401

Tuesday, Wednesday, Thursday, Friday 6 p.m. – 10 p.m., Saturday and Sunday 8 a.m. – 5 p.m.

This course includes instructional content for Building Constructions, Portable Extinguishers, and Fire Behavior. This course will present the candidate with the knowledge, skills, and ability to satisfy the requirements of NFPA 1001: Standard for Firefighter Professional Qualifications (2019 edition).

FIP 3044 FF Fireground Ops 4 (32 hours)

Section #2402

Tuesday, Wednesday, Thursday, Friday 6 p.m. – 10 p.m., Saturday and Sunday 8 a.m. – 5 p.m.

This course includes instructional content for Tools & Forcible Entry and Loss Control. This course will present the candidate with the knowledge, skills, and ability to satisfy the requirements of NFPA 1001: Standard for Firefighter Professional Qualifications (2019 edition). *Full turnout gear with SCBA required.*

FIP 3046 FF Fireground Ops 6 (28 hours)

Section #2403

Wednesday, Thursday, Friday 6 p.m. – 10 p.m., Saturday and Sunday 8 a.m. – 5 p.m.

This course includes instructional content for Ropes & Knots and Search & Rescue. This course will present the candidate with the knowledge, skills, and ability to satisfy the requirements of NFPA 1001: Standard for Firefighter Professional Qualifications (2019 edition).

Full turnout gear with SCBA and spare bottle required.

FIP 3050 FF Rescue Ops 1 (28 hours)

Section #2404

Wednesday, Thursday, Friday 6 p.m. – 10 p.m., Saturday and Sunday 8 a.m. – 5 p.m.

This course includes instructional content for Rescue. This course will present the candidate with the knowledge, skills, and ability to satisfy the requirements of NFPA 1001: Standard for Firefighter Professional Qualifications (2019 edition).

Full turnout gear without SCBA required.

FIP 3600 D/O: Emergency Vehicle Driver (24 hours)

Section #2405

Thursday and Friday 6 p.m. – 10 p.m., Saturday and Sunday 8 a.m. – 5 p.m.

This course deals with the safe operation of emergency vehicles, driving skills, legal implications of emergency driving, departmental standard operating procedures, and abilities to satisfy the key requirements of NFPA 1002: Standard for Fire Apparatus Driver/Operator Professional Qualifications (2017 edition).

Students must be 18 years of age and possess a valid NC Driver License.

Clothing appropriate for weather conditions recommended.

FIP 5712 TR: Vehicle Rescue: Vehicle Anatomy/New Technology (8 hours)

Section #2406

Sunday 8 a.m. – 5 p.m.

This certification-related course in vehicle anatomy and new technologies will present the Technical Rescuer (TR) with information on vehicle anatomy and will introduce new technologies in vehicle devices which present hazards for rescue personnel. Topics included in this course are vehicle construction, crumple zones, bumper systems, air bags, side-impact protection systems, new vehicle innovations, propulsion systems, passive safety systems, and active safety systems. Suggestions on how to cope with innovative vehicles to safely mitigate a modern vehicle rescue will also be discussed.

FIP 5715 TR: Vehicle Rescue: Victim Management (12 hours)

Section #2407

Friday 6 p.m. – 10 p.m. and Saturday 8 a.m. – 5 p.m.

This certification-related course in victim management will present the Technical Rescuer (TR) with proper methods for the movement of patients from a hazardous situation while focusing on the safety and well-being of the patients and rescuers. Stabilizing the situation, gaining access, packaging, and removal patients from vehicle rescue incidents will be emphasized in this course. Other topics include various techniques for displacing and removing a door, opening a roof, lifting a dash, pulling a steering wheel, pulling a seat, gaining access into the passenger compartment through the floorboard, gaining access into the passenger compartment through the trunk, and gaining access to a trapped victim under a roof of an upside down vehicle.

Full turnout gear without SCBA required.

FIP 3718 Fire Officer 1 (36 hours)

Section #2408

Monday, Tuesday, Wednesday, Thursday, Friday 6 p.m. – 10 p.m., Saturday and Sunday 8 a.m. – 5 p.m.

This certification-related course covers the knowledge, skills, and requirements referenced in the National Fire Protection Association (NFPA) 1021 Standard, 2020 edition, for Fire Officer I training. Topics include officer roles and responsibilities, community risk reduction, budgets, fire cause determination, inspections, education, leadership, management, public relations, and other requirements included in the NFPA standard.

Required Manual: IFSTA Fire & Emergency Services Company Officer (Sixth Edition)

ISBN: 978-0-87939-650-3

Option 1: *Fire Officer 1 Certification - The candidate must be at least 21 years of age, have a high school diploma or equivalent (i.e., GED), TIMS (FIP 7000), Firefighter certified for three years, and Instructor I certified.*

Option 2: *TRD0070 - Volunteer Fire Officer ISO580C Training Credit - Any person who successfully completes the Fire Officer level 1 certification course should receive NC Office of State Fire Marshal TRD0070 - Volunteer Fire Officer ISO 580C training credit. Meeting the prerequisites for Fire Officer Level 1 Certification are not required. Only successful completion of a FIP 3718 - Fire Officer Level 1 course will grant this credit. This credit gives Fire Departments the availability to train their volunteer fire officers to a NFPA 1021 based program, while gaining credit toward ISO credit. A person may continue to pursue the NC Fire Officer Level 1 Certification if they successfully complete the prerequisites.*

NFA Courses

TRT 0151 Courage to Be Safe - CTBS (4 hours)

Section #2409 *(Select 2400 is you want all 4 NFA Courses)*

Friday 6 p.m. – 10 p.m.

This course is a provocative and moving presentation by the National Fallen Firefighters Foundation, through the Everyone Goes Home® Program, that is designed to change the culture of accepting the loss of firefighters as a normal occurrence.

Building on the untold story of line of duty death survivors, it reveals how family members must live with the consequences of a firefighter death. This presentation provides a focus on the need for firefighters and officers to change fundamental attitudes and behaviors to prevent line of duty deaths. The central theme promotes the courage to do the right thing to protect yourself and other firefighters and ensure that “Everyone Goes Home” at the end of the day.

Firefighters must have the courage to face a multitude of risks to save lives and protect their communities. Their courage allows them to willingly risk their own lives so that others can be saved. A different type of courage is required to stay safe in potentially dangerous situations, avoiding needless risks and tragic consequences.

TRT 0152 Leadership, Accountability, Culture, and Knowledge – LACK (4 hours)

Section #2410 *(Select 2400 is you want all 4 NFA Courses)*

Saturday 8 a.m. – 12 p.m.

Is your department on the path to a LODD? This compelling presentation by the National Fallen Firefighter Foundation examines the root causes of LODDs and the role of Leadership, Accountability, Culture and Knowledge as it influences the result. Many fire departments across the United States “LACK the Right Stuff” to prevent them from being on a path to a line of duty death, with Leadership, Accountability, Culture and Knowledge being the elements that need to be addressed and managed in those environments. Through education and training, those departments can improve their survivability by understanding the root causes of firefighter fatalities and tackling these four elements with special emphasis on understanding fire service culture.

TRT 0153 Leadership So Everyone Goes Home – LEGH (4 hours)

Section #2411 *Select 2400 is you want all 4 NFA Courses)*

Saturday 1 p.m. – 5 p.m.

A course of the Everyone Goes Home® Program of the National Fallen Firefighters Foundation designed to assist in the reduction of LODDs utilizing a series of case studies. Each study will include what happened, why it happened, what could have avoided it, were safety measures available and used, and how can we prevent this in the future. The benefit of this program is the review of cultural change or adaptive challenge, rather than just enacting a technical fix, which in most cases does not work. A great program for senior fire officers and administrative officers. This is learning from actual incidents!

TRT 0154 Attributes of Leading -AOL (6 hours)

Attributes of Leading (AOL) is designed to build more effective fire service leaders of all ranks. is a highly interactive, real-world applicable, case study-based course. The program focuses on twelve essential qualities of effective leading:

FIP 4717 ISO Inspection Process (8 hours)

This course will review all the factors in the ISO Public Protection Rating for cities and fire districts. This course will allow departments to improve the representation of the department for maximum credit, possibly lowering insurance premiums for property owners.
